Issues Resolved with this Release

Report Center	<ul style="list-style-type: none"> • Issue: Service providers without assigned hours were not being listed on the Work Request Details report, even if the providers were assigned to work requests. • Resolution: The Work Request Details report now shows all service providers assigned to a work request.
Report Center	<ul style="list-style-type: none"> • Issue: Time stamps for completed work requests in the Work Request Details report did not match the time stamps shown in the Work Request Workspace. • Resolution: Time stamps in the Work Request Details report now match those in the Work Request Workspace.
Report Center	<ul style="list-style-type: none"> • Issue: Service providers who were not assigned to a work request were appearing in the Service Provider column in the Work Request Ad Hoc report. • Resolution: The Work Request Ad Hoc report now only lists service providers assigned to a work request in the Service Provider column.

Leases	<ul style="list-style-type: none">• Issue: When users were performing a re-measurement, interest and depreciation calculations were occurring in the period after the re-measurement, rather than in the period when the re-measurement occurred.• Resolution: Interest and depreciation calculations now occur in the correct period.
Check In/Check Out Documents	<ul style="list-style-type: none">• Issue: Users reported issues when trying to use the new Check In/Check Out Documents feature in Monarch.• Resolution: The Check In/Check Out Documents feature will no longer enable for documents which have not been properly migrated in BIGCenter's migration tool.
