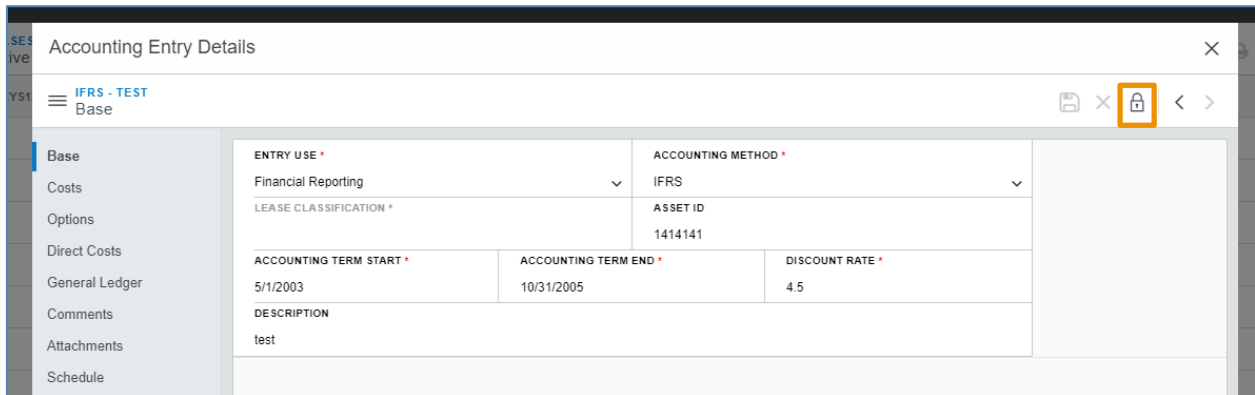

## Features & Enhancements

### Accounting Entry Details Action Dialog now has Lock for Approval action

Currently when you need to lock an accounting entry, you must exit out of the **Accounting Entry Detail** action dialog container and return to the **Accounting Entry Detail** section. If you then want to view the schedule once the entry is locked, you must return to the **Accounting Entry Detail** dialog container. This process reduces your efficiency by forcing you to make extra clicks.

The **Accounting Entry Details** action dialog now contains the **Lock for Approval** action. **Lock for Approval** will display with the other actions in the action dialog. This enhancement will save you clicks, and streamline your workflow by not forcing you to close the dialog and reopen it to view the changes.



## Issues Resolved with this Release

Component	Summary
Projects	<ul style="list-style-type: none"> <li><b>Issue:</b> While viewing an approved project from the <b>Budget Detail</b> section, users viewing the budget in <b>Detail View</b> have the ability to rename and delete memo lines. However, users reported that after renaming and deleting a memo line, the funds provided during the budget approval process were also removed from the budget.</li> <li><b>Resolution:</b> You can now rename and delete budget memo lines without also removing approved funds.</li> </ul>
