Features & Enhancements

Journal Entries dialog added to Accounting Entries record

The **Manage Accounting Entry** dialog in the **Accounting Entries** detail section of the **Leases** module has a new dialog called **Journal Entries**. This dialog shows you all journal entries for an accounting entry, including any changes due to remeasurement. This dialog will appear above the **Comments** dialog.

Accounting Term Start Date can now use Current Commencement Date

Previously, the system only allowed the Original Commencement Date to be used for the Accounting Term Start Date. Due to a customer request, we have now created the option to instead use the Current Commencement Date for the Accounting Term Start Date. To enable this feature, contact your Account Manager.
