Features & Enhancements

Lease Accounting Abstract print layout improved

The print layout for the Lease Accounting Abstract has been updated:

- Commas are now used globally in both currency and data values over 1,000.
- These fields are now included in the top section of the lease accounting abstract:
 - o Lease Commencement Date
 - o Original Lease Commencement Date
 - Lease Expiration Date
 - Possession Date
 - Lease Address
 - Name of person who input Lease Entry
 - Name of person who approved Lease Entry
- In the top section of the lease accounting abstract, the **File Client ID** and the **Asset ID** are now listed in separate fields.
- In the **Costs** section, cost records are now listed in descending order by start date.
- In the Direct Costs section, the Offsetting GL for the direct cost record has been added.



Issues Resolved with this Release

Component	Summary
Leases	A jump action has been created between Leases and the Building Manager .
Leases	 Previously, the Offsetting GL was an optional field when entering a Direct Cost in the Accounting Entry record. Due to a customer request, we have now created the option to make the Offsetting GL a required field. To enable this feature, contact your Account Manager.
