### **Issues Resolved with this Release**

Component	Summary
Leases	<ul> <li>After entering an initial Accounting Entry record, Leases was not generating a default start date for subsequent Accounting Entry records.</li> <li>Leases now generates a default start date for all Accounting Entry records.</li> </ul>
Leases	<ul> <li>Custom configuration settings in the <b>Options</b> and <b>Documents</b> detail sections were not persisting as users navigated between leases.</li> <li>These settings should now persist until the user makes another change.</li> </ul>
Leases	<ul> <li>Straight-line remeasurements were impacting the entire lease accounting schedule rather than from the date it was completed.</li> <li>Straight-line remeasurements should now be effective from the date they are completed.</li> </ul>
Leases	<ul> <li>Users reported that they were unable to edit the Activity Description field but they were able to edit Comments.</li> <li>The Activity Description field is now editable and Comments are no longer editable.</li> </ul>



Report Center	<ul> <li>The Project Summary Ad-Hoc Report was including project templates in its results.</li> <li>This report no longer includes project templates in its results.</li> </ul>
Work Requests	<ul> <li>Legacy Codes for buildings were only displaying when the Summary detail section was in Edit mode.</li> <li>Legacy Codes now display in the Summary detail section while in View mode.</li> </ul>
