## Summary of Issues Fixed and Additional Enhancements

Component	Summary
Leases	<p><b>Issue:</b> Customers reported that they were unable to open documents attached to leases that had been archived from within the upgraded version of BIGCenter.</p> <p><b>Resolution:</b> You are now able to open documents attached to archived leases.</p>
Leases	<p><b>Issue:</b> Customers reported that when attempting to print a lease abstract, their full lease accounting schedule did not display.</p> <p><b>Resolution:</b> Your full lease accounting schedule now displays on the lease abstract.</p>
Leases	<p>The costs listed in the <b>Costs</b> detail section of the <b>Manage Accounting Entry</b> modal window are now sorted so that the cost with the latest starting date is listed first.</p>

<p>Leases</p>	<p><b>Issue:</b> Previously, when you added a direct cost to a lease, the right of use asset was not adjusting.</p> <p><b>Resolution:</b> The system now adjusts the right of use asset when a direct cost is added to a lease.</p>
<p>Leases</p>	<p><b>Issue:</b> The <b>Leases</b> workspace was designed to disable the <b>Edit</b> action from the <b>Summary</b> detail section if the lease is archived. However, this means that users are unable to unarchive the lease.</p> <p><b>Resolution:</b> The <b>Edit</b> action is now available when a lease is archived to allow the user to unarchive the lease if necessary.</p>
<p>Leases</p>	<p><b>Issue:</b> Previously, lease accounting schedules included period 1 payments in the initial ROU Asset balance, but did not include them in the initial Lease Liability.</p> <p><b>Resolution:</b> Period 1 payments are now included in both your initial ROU Asset balance and initial Lease Liability. However, if your organization prefers not to include period 1 payments in your initial Lease Liability, this feature can be toggled off.</p>
<p>Lease Accounting Manager</p>	<p><b>Issue:</b> When using Internet Explorer 11 as a browser, customers reported that they were unable to fully configure general ledgers in the <b>Lease Accounting Manager</b>. Customers were unable to select items from the <b>Lease Classification</b> and <b>Type</b> drop-down menus.</p> <p><b>Resolution:</b> You are now able to select items from all drop-down menus as necessary.</p>
