This document describes the features and functionality of the BIGCenter 18.01.2 release. Enhancements have been delivered for the **Custom Field Manager** workspaces, **Leases** workspace, **Purchase Orders** workspace, and **Report Center**.

Summary of Issues Fixed and Additional Enhancements

Component	Summary
Custom Field Managers (all)	Users reported that the character limit for the Description field of a Choice Custom Field was too short. The character limit has been increased from 25 to 250 characters.
Leases	Issue: Users reported that when the Allocations detail section loads, the toggle is set to Future Allocations, but the toggle is instead showing the results for the All Allocations toggle. Resolution: The Toggle View action now displays only future allocations when the Future Allocations toggle is selected.

Leases	Issue: Users reported that the Documents detail section was not saving the document date. Users would enter a document date prior to the current date, save their changes, and leave the Documents detail section. Upon returning to the Documents detail section, they would find that the document date had reverted to the current date. Resolution: Document dates are now saved and maintained by the system as expected.
Leases	Issue: Users requested that fields unique to the legacy Lease Locational Report be made available as fields in the List View of Collections in the upgraded software. Resolution: You can now configure the List View of Collections to include the following fields from the legacy Lease Locational Report:
	 Address 1 Country Postal Code Floors Unit of Measurement Annualized Base Rent Amount / Area
Purchase Orders	Issue: After creating line items for a purchase order, the system was billing allocation items at 100%, even if the user entered a partial amount or partial percentage. This prevented users from billing multiple cost centers. Resolution: Users can enter partial amounts or partial percentages when entering allocation items, allowing them to bill multiple cost centers.
Report Center	Building Status and Tax Parcel ID filters have been added to the Building Information Filters group.
Report Center	Issue: Users reported that the Equipment Down Time report was returning an error message when users attempted to run the report. Resolution: The report now processes as expected.
