Sneak Peek: Company Manager and User Manager Workspaces!

We are hard at work developing two new workspaces for the upgraded software: the **Company Manager** and **User Manager** workspaces!

Company Manager

People records are organized under a parent company. The **Company Manager** workspace will give administrators the ability to manage the details of the companies they have built into the system.

User Manager

The **User Manager** workspace will give administrators the ability to manage people records and BIG users all in one place. In this workspace, you will be able to:

- View and Edit People records, as you would in **Legacy** via the **Admin > Admin Tools > People** page.
- View and Edit User Settings of other users, such as preferred language and currency.
- Assign people to a company.

Summary of Issues Fixed and Additional Enhancements

Component	Summary
Custom Field Manager	<p>Issue: After entering a value in a custom field of a record, the value did not appear in the custom field's column in the Collections pane.</p> <p>Resolution: After a value has been added to a custom field on a record, it will appear in the custom field's column in the Collections pane.</p>
Leases	<p>Issue: Previously, the discount rate was defaulting to the Original Start Date of the asset during re-measurement.</p> <p>Resolution: The system now defaults to the Effective Date of the discount rate during re-measurement.</p>
Leases	<p>Issue: The Print view of a lease accounting schedule was only displaying 120 periods when the schedule had more than 120 periods.</p> <p>Resolution: All periods for a lease accounting schedule now appear in the lease accounting Print view.</p>
Leases	<p>Issue: The County field in the Building Information section in Legacy was not available in the upgraded software.</p> <p>Resolution: The County field is now available in the Building Information section in the upgraded software.</p>
Report Center	<p>Issue: The lease Archived filter was not available for several reports.</p> <p>Resolution: The Archived filter is now available for these reports:</p> <ul style="list-style-type: none"> • Critical Date Forecast Report • Lease Accounting Ledger • Lease Ad Hoc • Location Summary Report • Ratios Report • Lease Invoice Details
Report Center	<p>Building ID, Level 2, Level 3, and Unit of Measure have been added as new Objects available for default lease reports in Report Center, with the exception of ad hoc reports.</p>

<p>Report Center</p>	<p>Issue: When selecting an End Date or To date, the system stopped reports from including anything after 12:00 am on the selected date.</p> <p>Resolution: The system now includes all data between 12:00 am and 11:59 pm on the End Date or To date in reports.</p>
<p>Report Center</p>	<p>Issue: When trying to adjust the formatting on a report they wished to export to PDF, users did not have the option to configure text wrapping.</p> <p>Resolution: Advanced formatting options are now available to all users. Right-click a column in Report Center to access the formatting modal window.</p>
