Summary of Issues Fixed and Additional Enhancements

Component	Summary
General	You can now search for a person using their Person ID in any type-ahead field that searches for person information. You can also add a new Person ID column to the Contacts detail section in the Leases workspace.
Leases	The Floors field is now editable from the Summary detail section.
Leases	A new object attribute has been created for the Accounting Entry Details modal window. When activated, this object attribute enables a Cost Center field in the Base detail section of the modal window. This field allows users to reference the cost center that an accounting entry should be assigned to. This field is information-only.
Leases	<p>Issue: The Rentable Area field in the Premises detail section did not display any decimal values.</p> <p>Resolution: The Rentable Area field in the Premises detail section now displays and allows up to a 4-digit decimal value for entry.</p>
Leases	<p>Issue: The SOX Audit report was not pulling changes made in several detail sections of the upgraded version of the software.</p> <p>Resolution: The SOX Audit report now pulls changes made in the upgraded version of the software.</p>
Leases	<p>Issue: The Comment Type field was not appearing on lease abstracts.</p> <p>Resolution: The Comment Type field now appears on lease abstracts.</p>
Leases	<p>Issue: The Allocation Type drop-down menu in the Leases > Allocations > Set Allocation Type modal window was not displaying all available options.</p> <p>Resolution: All allocation types now appear in the Allocation Type drop-down menu.</p>

Component	Summary
Leases	<p>Issue: The My Leases collection was not displaying lease records as expected.</p> <p>Resolution: The My Leases collection displays all lease records where the user abstracted the lease or is an active lease contact.</p>
Purchase Orders	<p>A new PO Total line has been added to the Line Items detail section. This line allows you to see the grand total of all line items currently associated to the purchase order without having to navigate back to the Summary detail section.</p>
Purchase Orders	<p>Purchase order line items now pre-populate with the general ledger assigned at the project-level. The General Ledger field will still be editable at the purchase order-level.</p>
Purchase Orders	<p>Issue: Previously, change orders could be selected and printed when viewing a linked change order collection. Change orders should not be allowed to print individually, as change orders appear when printing the parent purchase order.</p> <p>Resolution: The Toggle Multi-Select action and Print action are disabled when viewing a linked change order collection.</p>
Report Center	<p>Issue: The Purchase Order report was displaying the AP System description rather than the AP System Code or description.</p> <p>Resolution: Users can now select whether to view the AP System Code or description on the Purchase Order report.</p>
Report Center	<p>Issue: The Locations Summary report was not pulling leases that did not include a value in the State field.</p> <p>Resolution: The Locations Summary report now pulls all leases, including those without a state listed.</p>
