Summary of Issues Fixed and Additional Enhancements

Company Manager	<p>The following filters have been added to the Filter Panel in the Company Manager workspace:</p> <ul style="list-style-type: none"> • Name • Address 1 / Address 2 • City • State • Country • Tax Code
Leases	<p>Issue: Previously, the Parent Cost Center field from Legacy Portfolio Center did not display in the Allocations detail section of the Leases workspace.</p> <p>Resolution: A new object attribute has been created that adds the Parent Cost Center Code and Parent Cost Center Description columns to the Allocations detail section of the workspace. This object attribute also adds a read-only Parent Cost Center field to the Add, Edit, and View Allocation modal windows.</p> <p>To enable this feature, change the LEASE > SHOW_PARENT_COST_CENTER object attribute to VISIBLE.</p>
Leases	<p>Issue: Previously, when users attempted to cancel edits on an accounting entry, the system did not revert the values in the Accounting Entry Details modal window to the last saved values in the system.</p> <p>Resolution: When users cancel edits to an accounting entry, the system will refresh the Accounting Entry Details modal window and display the last saved values.</p>
Projects	<p>Issue: Previously, when users opened the Change Currency modal window in the Request for Proposal detail section, the Currency drop-down menu would display the default currency—for example, US Dollars—without indicating that this currency was the default currency for the project.</p> <p>Resolution: The Currency drop-down menu in the Change Currency modal window now displays the default currency for the project as Default, so that users can clearly see whether the default currency is currently selected.</p>

User Manager	<p>The following filters have been added to the Filter Panel in the User Manager workspace:</p> <ul style="list-style-type: none"> • Company • Name • Address 1 / Address 2 • City • State • Country • Vendor ID • Vendor Site Code • Person Code
Work Requests	<p>Issue: In situations where a work request was deferred prior to being completed, the system was not creating a completion event in the event log.</p> <p>Resolution: A completion event is created by the system when a work request is moved from Open to Completed status.</p>
