General	<p>Summary View Sorting is now enabled on mobile devices.</p>
Building Manager	<p>Issue: The system was not populating the latitude and longitude values for buildings with zip codes using the 5-4 digit format.</p> <p>Resolution: The system populates latitude and longitude values as expected.</p>
Leases	<p>Issue: When using the Save & Next function in the Income & Expenses detail section, the system was not respecting the sort order specified by the user.</p> <p>Resolution: When you resort the Income & Expenses detail section, the Save & Next function respects the sort order specified by the user.</p>
Leases	<p>Issue: When the object attribute COSTS_FORM.ASP CHARGECODE VISIBLE TRUE was disabled, the Charge Code column was still appearing in the Income & Expenses detail section grid.</p> <p>Resolution: When the object attribute COSTS_FORM.ASP CHARGECODE VISIBLE TRUE is disabled, the Charge Code column no longer appears in the Income & Expenses detail section grid.</p>
Purchase Orders	<p>An External Alias column has been added to the Line Items and Aggregated Line Items detail sections. This is an external reference number for aggregated purchase order line items.</p> <p>Additionally, the Configure Grid Settings action has been added to all grids in the Purchase Orders workspace and the Invoices workspace.</p>
Report Center	<p>Completed By and Service Provider filters have been added to the Work Request Ad Hoc report.</p>
