Facility Center	<b>Issue:</b> Service provider names were displaying without spaces and with odd characters in the <b>Dispatch Matrix</b> .
	<b>Resolution:</b> Service provider names display as expected.
Lease Accounting Manager	Lease Liability has been added as an option in the Type drop-down menu in the General Ledger detail section.
Leases	<b>Sox Audit</b> reports now display changes to option costs, including adding, modifying, or removing option costs. Additionally, changes to data from the following fields will be displayed in the reports:

	<ul><li>OPEX Amount</li><li>Frequency</li></ul>
	Start Date
	End Date
	Vendor ID
Leases	<b>Issue:</b> The system was not including cost end dates in its calculations of the lease accounting end date.
	<b>Resolution:</b> The system now includes cost end dates in its calculations when recommending an end date for an accounting entry.
Invoices	A Delete Invoice Line Item API has been created. This API is controlled by the <b>ALLOW_API_INV_LINEITEM_CHANGE_WHEN_INV_APPR_CLOSED</b> sysparm.
User Manager	First and Last Name fields now appear in the Details section of the Summary detail section.
User Manager	<b>Issue:</b> The system was treating the <b>Vendor ID</b> field as required when creating a user record, when it should not have been required.
	<b>Resolution:</b> The <b>Vendor ID</b> field is no longer required when creating a user record.
