Summary of Issues Fixed and Additional Enhancements

Component	Summary
Leases	<p>Issue: Previously, fields in the Lease Dates section of the Create a Lease page were marked as required when the Lease Type was set to Owned.</p> <p>Resolution: If the Lease Type is set to Owned, the fields in the Lease Dates section of the Create a Lease page are optional, not required.</p>
Leases	<p>Issue: When editing allocations in the Leases workspace, users found that if they clicked in the area of the Start or End Date fields that is horizontally in-line with the name of the field, the Filter Panel opened, became stuck, and the Date Picker from the Start or End Date field broke off the modal window. This only occurred if the user had filtered the collection or opened the filter panel prior to clicking on the Start or End Date field labels.</p> <p>Resolution: This issue no longer occurs when editing allocations.</p>
Leases	<p>Issue: The Tenant Share field was not populating on the Print Abstract.</p> <p>Resolution: The Tenant Share field populates on the Print Abstract.</p>
Leases	<p>Issue: Some users found that they could not delete rent-related cost items from the Income & Expenses detail section. This issue only occurred for costs with single cost allocations.</p> <p>Resolution: Users can delete rent-related cost items from the Income & Expenses detail section as expected.</p>
Leases	<p>Issue: The Toggle View action in the Income & Expenses detail section would not allow users to change the view.</p> <p>Resolution: The Toggle View action in Income & Expenses detail section functions as expected.</p>
Leases	<p>Issue: Lease allocation percentages were not rounding correctly due to the allocation percentage being cut off, causing the system not to allow reconciliation.</p> <p>Resolution: We have increased the amount of decimal values displayed for lease allocations to more accurately communicate percentage and allocation discrepancies.</p>

Component	Summary
Portfolio Center	<p>Issue: The Select Multiple function in the Hierarchy section of the Legacy > Portfolio Center > Lease > Reports page returned a server error.</p> <p>Resolution: This function no longer returns a server error.</p>
Report Center	<p>A new Lease Type filter has been added to Report Center. This filter allows users to create distinct reports for real estate and equipment leases.</p>
