## Summary of Issues Fixed and Additional Enhancements

Component	Summary
Documents	<p><b>Issue:</b> Users with the <b>MM/DD/YYYY</b> date mask setting found that documents were not sorting properly in the <b>Documents</b> detail section.</p> <p><b>Resolution:</b> Documents sort properly regardless of the date mask setting.</p>
Documents	<p><b>Issue:</b> Previously, items that appeared in the <b>Available Fields</b> field of the <b>Configure Grid Settings</b> modal window of the <b>Documents</b> detail section would disappear when the user closed the <b>Configure Grid Settings</b> modal window, manually reordered the columns, and then clicked the <b>Configure Grid</b> button.</p> <p>Items in the <b>Available Fields</b> field would re-appear if the user went to another detail section and then returned to the <b>Documents</b> detail section.</p> <p><b>Resolution:</b> Items that appear in the <b>Available Fields</b> field no longer disappear in the circumstances described above.</p>
Equipment Leases	<p><b>Issue:</b> The <b>LEASE &gt; SHOW_ACCOUNTING_COST_CENTER</b> object attribute did not make the cost center appear in the <b>Equipment Lease</b> workspace &gt; <b>Accounting Entries</b> detail section &gt; <b>Accounting Entry Details</b> modal window &gt; <b>Base</b> detail section.</p> <p><b>Resolution:</b> The <b>LEASE &gt; SHOW_ACCOUNTING_COST_CENTER</b> object attribute now makes the cost center appear in the <b>Base</b> detail section of the <b>Accounting Entry Details</b> modal window.</p>
Leases	<p>A new object attribute has been added that allows the <b>Asset ID</b> field in the <b>Base</b> detail section of the <b>Accounting Entry Details</b> modal window to be edited regardless of the status of the accounting entry. This allows users to update the Asset ID without having to re-measure the accounting entry. The object attribute that controls this feature is <b>LEASE &gt; EDIT_LEASE_ACCOUNTING_ASSET_ID</b>.</p>

Component	Summary
Leases	<p><b>Issue:</b> When premises changed on a lease, the lease allocations zeroed out rather than adjusting for the change.</p> <p><b>Resolution:</b> When a premise is changed, the system displays a message that reads: <i>Deleting this premise will change your allocation type to Percent, do you want to proceed?</i></p> <p>If the user clicks <b>Yes</b>, the allocation type changes to <b>Percent</b> and the allocation values remain the same. If the user clicks <b>No</b>, the record is not saved.</p>
Leases	<p><b>Issue:</b> Previously, if a user attempted to delete the file type extension from a document name—for example, .pdf, .xlsx, .docx—and then saved the document name, the system would not delete the file type extension. The user would have to delete the file type extension, double-click to select the whole name, and then save for changes to be saved.</p> <p><b>Resolution:</b> Once any changes made to a document name are saved, the system retains the changes.</p>
Leases	<p><b>Issue:</b> Previously, when the result of a classification test changed the lease classification of a lease, the system did not automatically update the general ledgers.</p> <p><b>Resolution:</b> Now, the system asks if the user wants to update their general ledgers when a classification test changes their lease classification. If the user clicks <b>Yes</b>, the system automatically updates the general ledgers.</p>
Leases	<p><b>Issue:</b> Previously, in the <b>Contacts</b> detail section, the system did not display the full Vendor ID code in the <b>Vendor ID</b> field if it exceeded 50 characters.</p> <p><b>Resolution:</b> Now, the system has a smart tool tip that displays the full vendor ID when the vendor ID length extends past the end of the field.</p>
Leases	<p><b>Issue:</b> Re-measured lease accounting schedules included all direct costs, even if they were factored into the original schedule.</p> <p><b>Resolution:</b> A flag now appears on direct costs that were included in the original schedule. When the user re-measures a lease accounting schedule, the system now only includes direct costs where the <b>Included</b> flag is set to <b>Yes</b>.</p>

Component	Summary
Leases	<p><b>Issue:</b> Previously, the system returned an error if the user attempted to create a new option type from the <b>Add Option</b> modal window.</p> <p><b>Resolution:</b> The system no longer returns this error.</p>
Project Template Manager	<p><b>Issue:</b> Previously, the selected view in the <b>Toggle View</b> drop-down menu of the <b>Budget</b> detail section did not display as bold and blue. This made it difficult for users to tell which view they were currently seeing.</p> <p><b>Resolution:</b> The selected view in the <b>Toggle View</b> drop-down menu now displays as bold and blue.</p>
Report Center	<p>A new object attribute has been created that allows the user to add the legacy <b>File ID</b> field to reports in <b>Report Center</b>. To enable this feature, set the object attribute <b>LEASE &gt; LEGACY_LEASE_ID</b> to <b>VISIBLE</b>.</p>
