## Summary of Issues Fixed and Additional Enhancements

Component	Summary
Leases	<p><b>Issue:</b> Previously, there was no object attribute that controlled the ability to create invoices.</p> <p><b>Resolution:</b> Now, the object attribute <b>Lease &gt; INVOICE_CREATE</b> controls whether a user class has the ability to create invoices.</p>
Leases	<p><b>Issue:</b> A customer reported that they received an error when attempting to generate a print abstract. The BIGCenter team determined that this error occurred when an option-type custom field was saved with a value, and then its value was removed, and saved again.</p> <p><b>Resolution:</b> Print abstracts now generate as expected.</p>
Leases	<p><b>Issue:</b> The <b>Archived</b> field was not appearing on print abstracts.</p> <p><b>Resolution:</b> The <b>Archived</b> field now appears on print abstracts.</p>
Leases	<p>The <b>LMD_MAIN.ASP.AMOUNT_REFUNDED</b> object attribute now toggles the following settings:</p> <ul style="list-style-type: none"> <li>• Shows / Hides the <b>Refund Amount</b> field in the <b>Add / Edit Security Deposit</b> modal windows.</li> <li>• Shows / Hides the <b>Refund Amount</b> column in the <b>Security Deposit</b> detail section.</li> <li>• Shows / Hides the <b>Refund Amount</b> field in the print abstract.</li> </ul> <p>Additionally, the BIGCenter team made modifications to the <b>LMD_MAIN.ASP.REFUND_DATE</b> object attribute, which now toggles the following settings:</p> <ul style="list-style-type: none"> <li>• Shows / Hides the <b>Refund Date</b> field in the <b>Add / Edit Security Deposit</b> modal windows.</li> <li>• Shows / Hides the <b>Refund Date</b> column in the <b>Security Deposit</b> detail section.</li> <li>• Shows / Hides the <b>Refund Date</b> field in the print abstract.</li> </ul>
