Modifications to the Options detail section in the Leases and Equipment Lease workspaces

The BIGCenter team has consolidated some functions in the **Options** detail section of the **Leases** and **Equipment Lease** workspaces. The following changes have been made:

- The **Edit Option** modal window is now labeled as the **Option Details** modal window.
- The **Comments** field in the **Base** detail section has been relabeled as **Option Note**.
- You can add, edit, and delete comments on an option in the **Comments** detail section of the **Option Details** modal window.

Note: Notes and comments have a limit of 1,000 characters.


- Previously, option costs were managed using the **Manage Option Costs** action. Now, option costs can be managed in the **Option Costs** detail section of the **Option Details** modal window.

Manage your lease options

To manage your options, follow the steps below:

1. Open the **Leases** or **Equipment Lease** workspace.
2. Select the lease whose options you want to manage.
3. Select the **Options** detail section from the **Detail Section** menu.
4. Select the option whose details you want to manage.

- Click the **Manage Option** button  in the toolbar on the right side of the **Details** pane. The **Option Details** modal window opens.

New Lease Options with Comments report created

A new Reportwriter report has been created for use with this enhancement. The **Lease Options with Comments** report returns a list of all comments associated with a lease option, with each comment listed as a separate line. The **Lease Options with Comments** report can be accessed via **Legacy > Portfolio Center > Lease > Reports**.
