# Summary of issues fixed and additional enhancements

Component	Summary
Leases	<ul> <li>The Published Date field now provides a date stamp when the Published flag is set to Yes.</li> <li>The Published By field now populates with the user's name when the Published flag is set to Yes.</li> <li>Note: These fields do not appear in the Leases workspace, but they do appear in some reports.</li> </ul>
Leases	Issue: When clicking the Save button after creating a new lease, the system did not appear to save the lease. However, the lease later appeared in the system.  Resolution: Leases can be created as expected.
Leases	Issue: Users should have been able to enter up to 6 decimal places in the Discount Rate field, but the system only allowed 2 decimal places.  Resolution: The system now allows users to enter up to 6 decimal places in the Discount Rate field.
Leases	Issue: Changing the value in the Lease Notification drop-down menu from No Later Than to N/A in the Options detail section made it so some clients could not manage activity records.  Resolution: Changing the value in the Lease Notification drop-down menu from No Later Than to N/A in the Options detail section no longer causes issues in the Activities detail section.
Portfolio Center	Issue: Previously, there was a 1,000 cap on how many recurring invoices could be created at the same time.  Resolution: The cap has been removed.
Report Center	Transaction custom fields are now available to add to a report in <b>Report</b> Center.



Component	Summary
Report Center	<b>Issue:</b> Some clients were unable to run the <b>Action</b> report.
	Resolution: The Action report runs as expected.
