Leases	<p>Issue: When creating a new lease, the Current Commencement Date was not marked with a red asterisk to show that the field was required.</p> <p>Resolution: The Current Commencement Date is now marked with a red asterisk to show that the field is required.</p>
Report Center	<p>Issue: The Project Ad Hoc report did not include projects currently in development—only projects with statuses that were Approved or later in the projects workflow.</p> <p>Resolution: When filtering by project status, the Project Ad Hoc report displays all projects and their status.</p>
