## Summary of issues fixed and additional enhancements

Component	Summary
Leases	<p><b>Issue:</b> When a user re-measured an accounting entry, the change in the asset balance was not reflected in the journal entry.</p> <p><b>Resolution:</b> Journal entries display the updated asset balance when an accounting entry is re-measured.</p>
Leases	<p><b>Issue:</b> Users found that the cost center would disappear from their accounting entry in the following scenario:</p> <ol style="list-style-type: none"> <li>1. The user approved the accounting entry with a cost center.</li> <li>2. The user made changes to the lease options or costs.</li> <li>3. The system then displayed the re-measurement recommendation notice.</li> <li>4. The user dismissed the re-measurement recommendation notice.</li> <li>5. The user found that the cost center disappeared from the accounting entry.</li> </ol> <p><b>Resolution:</b> The cost center no longer disappears in this scenario.</p>
Report Center	<p>A new <b>Quarterly Quantitative Disclosure</b> report has been added to <b>Report Center</b>. This report functions similarly to the <b>Quantitative Disclosure</b> report, but it allows the user to select a quarter prior to being run.</p>
