Fix for legacy report formatting


After the change to the way legacy BIGCenter handled PDF outputs, some legacy reports needed to be reformatted. The new report format no longer had banded rows present in legacy outputs.

Additionally, some reports had too much white space between the header rows and the report data.

The excess white space between the header and the report data has been removed. The banded rows display in Firefox or Chrome by default, but they are not supported in Microsoft Edge. In order to print the banded rows in Internet Explorer, you must first enable a setting in your browser.

If you are printing from Internet Explorer, follow these steps to enable banded rows:

- 1. Click the File menu.
- Select Page Setup from the drop-down menu that appears.The Page Setup modal window opens.
- 3. Select the **Print Background Colors and Images** check box.

- 4. Click the **OK** button.
- 5. Print the report.



Summary of issues fixed and additional enhancements

Component	Summary
Accounting Period Manager, Leases	Issue: Previously, you could still delete an accounting entry for a period even after the period had been closed in the Accounting Period Manager. Resolution: You can no longer delete an accounting entry for a period after the period has been closed.
Building Manager	Issue: The legacy Use field was not pulled over to the Building Manager workspace in the upgraded software. Resolution: The Use field now appears in the Summary detail section of a building record in the Building Manager workspace.
Leases	Issue: If a user changed the start date of a classification test when creating a re-measured accounting entry, the system would ask the user if she would like to override the original start date of the accounting entry. The classification test should not override the details of the original accounting entry unless the user is editing the original accounting entry. Resolution: If the user chooses to override the start date of the accounting entry, the system updates the Effective Date instead of the Accounting
	Term Start Date.
Leases	Issue: If a direct cost was added to a re-measured accounting entry, the direct cost was not included in the accounting schedule.
	Resolution: Direct costs are included in remeasured accounting schedules.
Reports	The Option ID field has been added to the Report Writer - Lease Options report.
