New Ownership Details section in Leases workspace

If you select **Owned** from the **Leased/Owned** drop-down field in the **Create Lease** page, a new **Ownership Details** section now appears. This section contains informational fields from legacy that were used to track ownership data.

The fields which appear are as follows:

- **Ownership** – Select from user-defined ownership descriptions.
- **Condominium** – Enter details about co-ownership in this field.
- **Purchase Cost** – Enter the purchase cost of the property in this field.
- **Purchase Date** – Enter the purchase date of the property in this field.
- **Sale Date** – Enter the date that the property was sold. This should be populated prior to the lease being archived.

Approval Limits display in Lease Invoice workspace

When you select lease invoices to approve, your **Expense Invoice Threshold** and your **Income Invoice Threshold** now appear in the **Summary** detail section of the **Approve Invoices** modal window. These fields display your approval limits for expense and income invoices.

Additionally, if you open the **Ineligible Invoices** detail section and scroll to the right, two columns appear which may help you understand why you cannot approve the invoice.

- The second-to-last column is the **Amount Total Invoice** column, which displays the total amount of the invoice.
- The last column is the **Ineligible Reason** column, which displays the reason an invoice is ineligible for approval.

Leases	<p>Issue: A client reported that the export failed when she attempted to export the Collection view of the Leases workspace. The client determined this issue was related to custom date fields.</p> <p>Resolution: Custom date fields no longer cause the Collection view export to fail.</p>
Report Center	<p>The Activity Description and Activity Notes fields have been added as report objects to the Activity Log report.</p>
