Summary of issues fixed and enhancements

Component	Summary
Leases	Issue : When an offsetting GL was added to the Direct Costs detail section, the Journal Entries detail section was not being updated.
	Resolution : The Journal Entries detail section will now update with the correct general ledgers when direct costs are added to an accounting entry and the entry is remeasured.
Leases	Issue: The Schedule detail section of the Accounting Entry Details modal window was limited to 120 rows.
	Resolution : This limitation has been removed. You can now view up to 1020 rows.
Leases	Issue : When printing an Accounting Entry , comments associated with the accounting entry were not included in the full print.
	Resolution : When printing an Accounting Entry , the Comments section is now included in the full print.
Lease Invoice	A Period Range filter has been added to the Filter Panel in the Lease Invoice workspace, allowing you to filter between a specific range of dates. Additionally, custom filters created in the Leases workspace are now available in the Filter Panel of the Lease Invoice workspace.
