New Reject and Void features in Lease Invoice Workspace

The newest enhancements to the **Lease Invoice** workspace are the options to reject and void invoices that are in **Pending Approval** status. These new actions allow you to easily reject invoices that are pending approval, in the event of unfinished services, or void them, in the event of duplicate submissions.

To use this new action, follow the steps below:

- 1. Open the Lease Invoice workspace.
- 2. Click the **Filter** button \mathcal{V} in the toolbar on the right side of the **Collections** pane. The **Filter Panel** opens.
- 3. From the Status drop-down menu, select Pending Approval.
- Click the Check Mark button ✓ at the top of the Filter Panel to apply your filter. All invoices with a status of Pending Approval appear in the Collections pane.
- 5. Choose between two options:
 - To reject or void all invoices with a status of **Pending Approval**, proceed to step 6.
 - To reject or void specific invoices for approval:
 - a. Click the **Toggle Multi-Select Mode** button $\ensuremath{\textcircled{}}$ in the toolbar on the right side of the **Collections** pane.
 - Check boxes appear to the left of the left-most column of the **Collections** pane.
 - b. Select the check boxes next to the invoices you want to reject.
- 6. Click the **Approve Invoices** button **L** in the toolbar on the right side of the **Collections** pane. The **Approve Invoices** window opens.
- 7. Choose between two options:
 - To reject the invoices:
 - a. Click the **Reject Invoices** button imes in the top right corner of the window.
 - A dialog box opens, asking you to confirm your choice.
 - b. Click **OK**.
 - The window closes. The status of the invoices is changed to **Open**.
 - To void the invoices:
 - a. Click the **Void Invoices** \bigcirc button in the top right corner of the window.
 - A dialog box opens, asking you to confirm your choice.
 - b. Click **OK**.
 - c. The window closes. The status of the invoices is changed to Void.
