# Legacy Custom Fields now available for use in Property Detail Section of Building Manager workspace

Now you can work with your legacy BIGCenter property custom fields in the updated BIGCenter **Building Manager** workspace. These fields can be used to customize reports.

To work with custom fields:

- 1. In the Updated BIGCenter, click **Site Administration**. The **Site Administration** dialog box opens.
- Click Building Manager.
  The Building Manager workspace opens in the main window.
- 3. Select the record to add custom fields to.
- 4. Select **Property** from the **Detail Section** menu.
- Click the Edit Property Custom Fields button .
  The Legacy Property Form opens in a new browser window.
- 6. Scroll down to the **Custom Fields** section to enter your data.
- 7. Click **Save** ... Your property custom fields are now available for use with reports.



## Summary of issues fixed and additional enhancements

Component	Summary
Lease Invoice	The general ledger associated with an expense item will now display when you select an expense to view or edit.
Lease Invoice	Line item summation for new invoices has been improved. Now line items for invoices that don't equate to the total invoice amount are ineligible for approval, and the <b>Send for approval</b> action is inaccessible.
Leases	We've fixed a bug that displayed an error when editing the cost of Items and expenses.
