You may also remember that in the 20.05.2 release we added a **What's New** link in the menu in the header bar of the upgraded BIGCenter.

ΑΡΙ	The API now checks to see if there are line items and allocations on an invoice or purchase order before allowing the invoice or purchase order to be approved.
Programs workspace	Budget transfers between projects at the program-level work as expected even if there are no budget categories on the projects.



Component	Summary
Projects workspace	The values in the <b>General Ledger</b> field in the <b>Summary</b> detail section now sort in ascending order by GL code when the detail section is in <b>Edit</b> -mode.
Work Requests workspace	The <b>Event Log</b> detail section now captures the correct user data on events.
